Re: Audit of Perry County Sheriff Firearm Permits

Dear Commissioners:

This letter will serve to confirm the engagement of our firm to represent the Perry County Auditors in the above matter and will set forth the general basis upon which fees are to be charged by our firm. This agreement will become effective upon our receipt of a counter signed copy of this letter.

The standard hourly fee for my services is currently \$270.00 per hour. Work on your case done by an associate will be billed at the current hourly rate of \$200.00. Where possible, I will assign work on the matter to a law clerk or paralegal who will be billed at their current rate of \$175.00 and \$165.00 per hour, respectively. The firm reviews and changes standard rates in January of each year. The approval of the Perry County Board of Commissioners dated March 31, 2014 is limited to a total initial expenditure for legal fees not to exceed \$2,000.00. Prior approval of the Perry County Board of Commissioners shall be required before incurring legal fees in excess of \$2,000.00.

The firm will provide a detailed bill when work is completed or, if information gathering, or discussions and decisions on what is needed are protracted, on a monthly or quarterly basis, showing time spent since the previous bill. In addition to our fees, our statements for services rendered will include specific expenses advanced by the firm on your behalf, along with a charge for expenses incurred by the firm for such items as travel costs, delivery/messenger services, photocopies, telephone and telefacsimiles, and computerized research (including Westlaw, Lexis/Nexis, the internet, etc.).



Please acknowledge your receipt of this letter and your acceptance of its terms and conditions by signing the enclosed copy.




