Good morning, Patrick.

Regarding your questions on the legal defense fund (after consulting with Tracey), we couldn't find an IRS definition for "public purpose", but found an article with this quote (which isn't guidance, but more of a thought): "So, when would a gift to a local government not be "for exclusively public purposes"? I'm not a tax expert, but I would think that most gifts to local governments would be given only for public purposes. The IRS code does not specifically define "public purpose," but it has been interpreted in part to mean that the contribution or gift must not be intended to benefit any particular individual." In the end, this might be more of a legal question that you could possibly consult with your solicitor if it is a concern.

We couldn't think of any outside requirements that would disallow expenses paid out of the income, but the City may want to be careful with the wording used in soliciting the funds themselves - i.e. "100% of funds raise will be used to XXX", might preclude certain expenses to be charged.

I talked to Alex and he is going to get everything set up on the payment side of things as he described below.

For now, as the Solicitor finalizes his determination on the tax-deductible eligibility of contributions, there will NOT be anything on the site that mentions contributions being tax-deductible.

We'll use this phrase below to describe what people are donating for:

"Your contribution will be used to defend the City of Lancaster against the NRA lawsuit and to advocate for common sense laws to protect our communities."

After we get the legal ruling on tax deductibility and also deal with some of the paperwork that PayPal requires for this, Alex will add the verbage about tax-deductible contributions, include it on the email receipts that donors get, etc.

We can then follow up with any donors who contributed early on with our own receipt noting the tax-deductibility of their contribution.

Alex also said they will capture all of the email addresses in a MailChimp database so we can use that for blast emails to donors, etc. (Don't worry about what that means, Amber knows!)

For now, he wants the ZPNA invoices related to the NRA lawsuit to be paid as usual out of the General Fund Solicitor line item. I assume that we can go back after the fact and recognize revenue from the defense fund if we want to as long as it's during the same year of the invoice we paid?

I want to keep a scanned copy of each of their monthly invoices for the NRA lawsuit (I have January) since I'm sure we'll get requests for information on how much we've spent on the defense, etc.
